



## Emergency Message for U.S. Citizens: Belize, Hurricane Warning (Tropical Storm Ernesto)

This Message is to alert U.S. citizens residing and traveling in Belize that Tropical Storm Ernesto has been upgraded to a category 1 hurricane, and to alert U.S. citizens to the potential dangers posed by the storm.

A hurricane warning is in effect for Belize.

The National Hurricane Center reports that Hurricane Ernesto is located near latitude 18.5 North, longitude 85.5 West, approximately 250 miles east of Belize City. Ernesto is moving toward the west-northwest at nearly 14 mph (22 km/h). Maximum sustained winds are 80 mph or 130 km/h.

The Belize National Emergency Management Organization (NEMO) continues voluntary evacuation through Tuesday, August 7, 2012, from San Pedro, Ambergris Caye, as well as Caye Caulker. Please monitor Belize media reports for the latest updates on future evacuations.

Peace Corps volunteers in northern Belize and the Belize City District are being evacuated inland to Belmopan. Peace Corps volunteers in southern Belize are being evacuated north to Punta Gorda.

U.S. citizens are urged to locate shelter, monitor media reports, and follow all official instructions. U.S. citizens should carry their travel documents at all times (i.e. U.S. passport, birth certificate, picture ID's, etc.) or secure them in safe, waterproof locations. We also suggest that U.S. citizens contact friends and family in the United States with updates about their whereabouts.
