



Emergency Message for U.S. Citizens: Amsterdam (The Netherlands), Increased Vig

Given recent events in Libya and Egypt, the U.S. Mission to The Netherlands encourages all U.S. citizens living in or visiting The Netherlands to review their personal security measures and adjust those measures as appropriate.

Although at this time there is no credible or specific threat to U.S. Citizens in The Netherlands or our diplomatic staff and facilities, a periodic reassessment and adjustment of your security habits and practices is always a good idea. We encourage all U.S. Citizens in The Netherlands to exercise common sense security measures. Be especially cautious if you must enter areas where you may be easily identified as a target of crime or violence. These include crowded subways, train stations, elevators, tourist sites, market places, festivals and crime-ridden neighborhoods. Avoid public demonstrations and other civil disturbances. If at any time you feel threatened or in danger, please call the Dutch authorities immediately by dialing 1-1-2 for emergency service response from Dutch police, rescue, and fire departments.

The State Department issued a Worldwide Caution on July 18, and we would like to take this opportunity to remind U.S. Citizens in The Netherlands that the U.S. government remains concerned about the continued threat of terrorist attacks, demonstrations, and other violent actions against U.S. citizens and interests overseas. Review your personal security plans, remain aware of your surroundings, including local events, monitor local news stations for updates, and report specific incidences of targeted violence to the U.S. Embassy in The Hague or the U. S. Consulate General in Amsterdam at the numbers below. Maintain a high level of vigilance and take appropriate steps to enhance your personal security. For additional information, please refer to "A Safe Trip Abroad." We strongly recommend that U.S. citizens traveling to or residing in The Netherlands to enroll in the Department of State's Smart Traveler Enrollment Program at www.Travel.State.Gov. Enrollment gives you the latest security updates, and makes it easier for the embassy or nearest consulate to contact you in an emergency. If you don't have Internet access, enroll directly with the nearest U.S. embassy or consulate.

Regularly monitor the Department's website, where you can find current Travel Warnings, Travel Alerts, and the Worldwide Caution. Read the Country Specific Information for The Netherlands. Contact the embassy or consulate for up-to-date information on travel



restrictions. You can also call 1-888-407-4747 toll-free in the United States and Canada or 1-202-501-4444 from other countries. These numbers are available from 8:00 a.m. to 8:00 p.m. Eastern Time, Monday through Friday (except U.S. federal holidays).
